Terms and Conditions

1. The EasyFX Travel Photo competition is open to anyone aged 18 years or over. However, winners must be able to receive payment electronically in GBP, EUR or USD. No other currencies will be disbursed. The operational team of VFX Financial PLC (VFX), including anyone associated with organising the competition and their immediate families, are excluded from participating.

We are looking for original images portraying women in diverse travel related settings, including rural, urban and seaside environments.

2. All information detailing how to enter this competition forms part of these terms and conditions. It is a condition of entry that all rules are accepted as final and that the competitor agrees to abide by these rules. The decision of the judges is final, and no correspondence will be entered into. Submission of an entry will be taken to mean acceptance of these terms and conditions.

3. Entries should be submitted by via Instagram. Entries must be tagged with @easyfxcard and the hashtag #WomenWhoTravel. We regret that we are unable to accept postal entries.

We will contact the winners to submit the original photograph by email. Image files must be at least 200 dpi and between 1MB and 3MB.

4. All entries must be received by the advertised closing time and date: 11.59pm (GMT) on 8th June 2018. A selection of images shared on Instagram will be displayed on our website. Please note this does not mean that they have been selected as final winners. Winners will be contacted in person.

5. All images submitted must be the work of the individual submitting them and must not have been published elsewhere or have won a prize in any other photographic competition. It is the responsibility of each entrant to ensure that any images they submit have been taken with the permission of the subject and do not infringe the copyright of any third party or any laws. Entrants must warrant that the photograph they are submitting is their own work and that they own the copyright for it.

6. Copyright in all images submitted for this competition remains with the respective entrants. However, in providing an image to be considered for the competition, each entrant grants a worldwide, irrevocable, perpetual licence to EasyFX and VFX PLC to feature any or all of the submitted images on their website and/or in any promotional material connected to this competition.

Copyright and using Images

Winning images will be featured on the EasyFX (a wholly owned and operated brand of VFX Financial PLC) website as part of a photo database. Images in the database will be released under the Creative Commons CCO protocol. Uploading Images

We will aggregate the images via Instagram where they will be reviewed. If selected, you will be required to provide pictures of the correct resolution. VFX Financial PLC will not accept any images containing adult content or any content that is considered inflammatory or harmful to others.

7. We will accept up to 5 entries per person. Late, illegible, incomplete, defaced or corrupt entries will not be accepted. No responsibility can be accepted for lost entries and proof of transmission will not be accepted as proof of receipt. Entries must not be sent through agencies or third parties.
8. The winning entries to be featured on our home page will be that that is judged to be the most visually appealing, original and self-explanatory. The winners will be notified within seven days of the closing date of the competition.
9. All selected winners will receive payment of £100 (or equivalent in EUR, USD). One selected winner will have their image featured on the EasyFX homepage for a period of time.
